Marking Non-Surgically Contracepted/Sterilized Animals:
Our project exploring the use of microneedle patches to tattoo an animal's ear progressed in 2020 despite several COVID challenges. Microneedle patches are being developed to administer the flu vaccine to humans, among other uses. Application is reported to be painless by both adults and children.
We've been working closely with Dr. Mark Prausnitz of the Georgia Institute of Technology to explore using these patches to tattoo the inside of a dog or a cat's ear to indicate that it has been non-surgically sterilized and/or vaccinated. We did a 2nd and 3rd pilot study in 2020 which helped advance product development. Work continues in 2021.

Two key projects including:
Free-Roaming Cat Population Modeling:
ACC&Ds team did custom modeling around COVID interruptions of spay/neuter in managed colonies. Results supported that prior efforts will pay off; we shared modeled data with the field to help them focus on how to strategically restart efforts. ACC&D's has published twice before on our modeling work. With support from consultant Dr. Phil Miller, Board member Dr. John Boone, economists from the USDA National Wildlife Research Center and several other volunteers on the modeling team we submitted a third manuscript, Policy Guidance for Management of Free-Roaming Community Cats: A Bioeconomic Analysis from our work

Evaluation of health benefits and risks of surgical sterilization in dogs:
ACC&D is partnering with Banfield the Pet Hospital and STATCOM at the University of Michigan on a project analyzing a large data repository on dog health from 2013 - 2019, as it relates to spay neuter. We anticipate a first publication in this area in 2021 on our pilot work.
Outreach and Education:
In 2020, ACC&D formed our International Advisory Board and held several meetings. COVID impacted many plans for speaking at conferences, closing some doors and opening several more. Our primary focus was around helping support

To achieve our mission, ACC&D provides scientifically sound and animal welfare-oriented resources to stakeholders, supports the appropriate distribution of available products suitable for the humane control of cat and dog populations, and facilitates research on topics relevant to the development, application, acceptance, and use of non-surgical fertility control methods.
ACC&D was formed in 2000. as a program of Auburn University. It was incorporated in 2005 as a stand-alone 501(c)(3). It has held six international symposia to convene researchers, academics, veterinarians, animal welfare professionals, and other stakeholders in advancing cat and dog fertility control with the most recent held in 2018. It inspired Dr. Michelson to create the \$75 million Michelson Prize and Grants program in 2008.
In 2020, the Organization was guided by a 10-member Board of Directors, a 14-member Science Advisory Board and an 8-member International Advisory Board. Several of these volunteers also contribute as the Scientific Advisory Board of the Michelson Prize and Grants program of the Found Animals Foundation, which has provided over \$17 million in grants since 2009 to nearly 40 projects toward development of a non-surgical sterilant(s) for dogs and cats.
ACC&D's Council of Stakeholders comprises leading organizations which provide key strategic and networking support as well as key financial resources to help ensure sustainability. Council members in 2020 include Alley Cat Allies, the American Society for the Prevention of Cruelty to Animals (ASPCA), Best Friends Animal Society, The Humane Society of the United States (HSUS), International Cat Care, Petco Foundation, PetSmart Charities, and the Regina Bauer Frankenberg Foundation.
ACC&D relies on grants from other not-for-profit organizations, private foundations, and individual major donors for its primary support.

female cats that entered a 2nd year breeding trial the end of 2020 -it was successful! That technology has moved into drug development based on the success, and work on dogs has begun. During this COVID-19 year, there was urgent need for alternatives to surgery. ACC&D re-evaluated a progestin, accessible and inexpensive via veterinary compounders, as an 'band aid' as an oral contraceptive for cats during pandemic related spay/neuter clinic shutdowns. We raised the support of our recommendation from a large number of national/international organizations, who contributed to outreach and education about this topic. We continue to provide support for veterinarians and shelters use this progestin or are considering it. Suprelorin, a contraceptive implant for male dogs, expanded to several countries in 2020 and is now in a total of 40. We published a review article on this technology and updated web and product profiles for this most-visited section of ACC&D's website. We continued to monitor several other research initiatives, providing guidance as appropriate and when helpful.
