

A few details of our launching:

- Zeuterin became our "default procedure" for male dogs, owners chose at check-in
- Surgical castration priced \$20 higher
- Cost of complications covered by FCNMHP
- Free surgical castration offered if owners changed their minds 1-6 months afterward
- Transports, rescue groups and municipalities were exempt

Initial reaction

- Ouch! Yuk!
- Remove price differential
- Enhance scrub and disinfectant protocol
- Word spread around, staff skeptical

Now

- 4 months since last adverse event
- Fewer Zeuterin procedures elected
- Much less time-efficient process

What is next:

- Resume price differential but at only \$10 less for Zeuters
- Offer FREE Zeuters to animal control agencies if they bring us their female dogs to spay
- Adding another dog ward where we may develop more sequential protocol
- Build numbers back up and efficiency
- Ask- was this our learning curve?
