Our key accomplishments in 2012 included the following:
On the Ground Use of New Products for Population Control
ACC&D supported several research projects during the year to help advance our cause -many of which were completed in 2013. We convened a team of experts to develop a computer simulation population model for free-roaming cat populations in which different surgical (and later non-surgical) interventions can be assessed for impact. ACC&D provided continued financial & strategic support for a study being conducted in Chile comparing the behavior of intact dogs with both castrated dogs and those neutered with Esterilsol(TM) the first non-surgical sterilant for male dogs.
ACC&D developed much educational material for the field in 2012. Extensive work

In 2012, ACC&D convened 10 experts to investigate "Controlled Release for Depot and Implant Technologies, as it Applies to Developing Non-Surgical Alternatives to Sterilize Cats and Dogs".
Additional expenses in this area related to preparing for ACC&D's 5th International Symposium on Non-Surgical Contraceptive Methods of Pet Population Control, held in mid-2013.

ACC&D is a not-for-profit organization formed in 2000 as a program of Auburn University and incorporated in 2005 as a stand-alone 501c3. ACC&D has held four international symposia to bring together researchers, academics, veterinarians, animal welfare professionals, and other stakeholders in cat and dog fertility control. The fifth symposium is planned for 2013. Based in Portland, Oregon, ACC&D relies on grants from other not-for-profit organizations, private foundations, and individual major donors for its primary support.

ACC&D is guided by a board of nine directors as well as an eleven-member International Science Advisory & Product Development Committee. Our small staff relies on key volunteer support from senior leaders, veterinarians, scientists and academics. Several of these volunteers also contribute as the Scientific Advisory Board of the Michelson Prize and Grants program of the Found Animals Foundation which has provided over \$10 million in grants toward development of non-surgical a sterilant/s for dogs and cats since 2009.

ACC&D has an Organizational Partners Program with 135 groups from 19 countries and 20 U.S. states. We also have a Council of Stakeholders-a group of leading organizations providing key strategic and networking support as well as key financial support to help ensure ACC&D's sustainability.
